Ineligible Categories for Financial Aid:

- Applicants for permanent resident status who have none of the above documentation.
- Persons with only a non-immigrant visa.
- Persons with only an employment authorization.
- Persons with family unity status
- Temporary residents allowed to live and work in the U.S. under the Legalization or Special Agricultural Worker program.
- Students with "Temporary Protected Status" stamped on their I-94 forms.
- Students granted Deferred Action for Childhood Arrivals (DACA) status.
- Students with a "withholding of removal" order issued by an immigration judge or by the Board of Immigration Appeals.
