The information you provide may be used to make corrections to your FAFSA if necessary.

**Who is my parent?** "Parent" means your legal (biological and/or adoptive parent). If your parents are unmarried and live together you must report information about both of them. Grandparents, foster parents, legal guardians, older siblings, and uncles or aunts are not considered parents unless they have legally adopted you. If your divorced or widowed parent has remarried, you must report information about your stepparent. If your parents are divorced or separated and *do not live together*, report information about the parent with whom you have lived more during the past 12 months. If you lived the same amount of time with each parent, report information about the parent who provided more financial support during the past 12 months, or during the most recent year you received support from a parent.
