#### Articulation Agreement between

#### PURPOSE OF AGREEMENT

This document establishes a transfer articulation agreement between Jamestown Community College (JCC) and Alfred State College (ASC). Its purpose is to afford students the opportunity to pre-plan their college careers, and to facilitate the transfer process from the Associate in Applied Science (AAS) degree program in Nursing or the AAS degree program in Occupational Therapy Assistant at JCC to the Bachelor of Technology (BTech) degree program in Healthcare Management at ASC. Students can choose to take their ASC coursework entirely online, entirely on-campus, or in any online/on-campus combination, and will have the opportunity to earn the BTech in Healthcare Management in two years with coursework equivalent to four semesters at ASC.

# GENERAL GUARANTEE OF ADMISSION, STANDING, AND OPPORTUNITY TO GRADUATE Students who graduate from JCC with a(n)

- AAS Nursing or AAS Occupational Therapy Assistant degree,
- minimum of 4 SUNY General Education categories fulfilled,
- minimum of 21 credits in Liberal Arts and Sciences courses, and
- minimum cumulative grade point average (GPA) of 2.00

are guaranteed admission with full junior status into the BTech Healthcare Management degree program at ASC and with the opportunity to graduate in four semesters.

Students who do not meet all of the above criteria will be evaluated for acceptance by ASC on a case by case basis.

#### GENERAL GUARANTEE OF TRANSFER OF CREDITS

AAS Nursing graduates automatically transfer a minimum of 60 credits. These include 27 credits that meet requirements for the BTech Healthcare Management degree: ENG 1530 (3 Liberal Arts & Sciences credits, meets SUNY General Education Basic Communication requirement), PSY 1510 (3 LAS credits, SUNY Social Sciences), BIO 2510 (4 LAS credits, SUNY Natural Sciences), MAT 1540 (3 LAS credits, SUNY Math), and 14 additional LAS credits (ENG 1510 – also meets SUNY Humanities requirement, PSY 2510, BIO 2520, BIO 2531, and BIO 2532).

AAS Occupational Therapy Assistant graduates also automatically transfer a minimum of 60 credits. These include 26 credits that meet requirements for the BTech Healthcare Management degree: ENG 1530, PSY 1510, BIO 2510, MAT 1500 or MAT 1540 (3 LAS credits, SUNY Math), and 13 additional LAS credits (ENG 1510 – also meets SUNY Humanities requirement, PSY 2560, SOC 1510, and BIO 2520).

AAS Nursing and AAS Occupational Therapy Assistant graduates can transfer any or all of these additional credits toward meeting additional requirements for the BTech Healthcare Management degree: up to three courses (9 credits) that meet three additional SUNY General Education requirements, CMM 1610 Public Speaking (3 credits), and an additional 3 credits (for AAS Nursing graduates) or 4 credits (for AAS Occupational Therapy Assistant graduates) of Liberal Arts and Sciences courses. Transferable JCC credits therefore total 75 credits (for AAS Nursing graduates) or 76 credits (for AAS Occupational Therapy Assistant graduates).
