License Agreement and Terms:

- The cost of housing for the summer session for a <u>JCC student</u> is \$750.00 per summer session. The cost of housing for summer <u>interns</u> not affiliated with the JCC summer session is \$150 per week or as otherwise negotiated by the Director of Residence Life and Executive Director of the Faculty Student Association. In addition, all summer residents must complete a \$200 security deposit, refundable at the end of the stay pending assessed cleaning and damage charges. Payments are due by the published payment deadlines. Students who fail to make payment by the due date(s) may have an academic hold placed on their account or their housing contract cancelled.
- 2. Occupants agree that housing and tuition fees will be paid by due dates and accept liability for any collection costs as a result of failure to pay including, without limitation, collection agency fees, court costs and attorney fees. Occupants must understand that if any portion of their account remains unpaid at the end of the semester, their account will be forwarded to a collection agency within 30 90 days. Occupants must also understand that Jamestown Community College may contact them by phone, e-mail, or text message regarding any outstanding account balance using any phone number, cell phone number or e-mail that was provided to the college.
 - a. Students of the College will be billed for summer housing with their student bill, which will be accessible through Self Service Banner.
 - b. Interns will be billed for summer housing through the Faculty Student Association, when applicable. In some instances, internship sponsors may arrange alternate arrangements with the FSA.
- 3. Occupants understand that if they choose to not be a responsible resident, they will face disciplinary action. If found responsible for actions causing damage to the residence hall or surrounding property, occupants will be liable to pay damages and face possible dismissal from the JCC Hillside Suites and may receive additional conduct sanctions.
- 4. All residence halls on the JCC Jamestown Campus are alcohol, tobacco and drug free. Residents who are found in possession of or knowingly in the presence of any of the aforementioned items may jeopardize their stay in the Hillside Suites. Violations of policies will be subject to judicial sanctions, as outlined by the Student Code of Conduct contained within the Constitution of the Student Body.
- 5. All JCC students requesting summer housing must either be participating in summer courses, a JCC sponsored internship, and/or have employment on-campus. Other instances for housing may be considered by the Director of Residence Life and/or their designee
- 6. It is understood and agreed that occupants accept and agree to the terms and conditions of this license and that they are responsible for adherence to all other policies specified in the FSA On-Campus Living Policies and the Constitution of the Student Body. These documents can be found on our website and will be published in each residence hall as well as in the residence life office on campus.
- 7. It is understood that the campus food service through the Jayhawks Café will not be available during the summer. Student services on campus will continue to operate as normal unless otherwise communicated through digital signage in the Hillside Suites lobbies, email, social media, and/or verbal communication.
