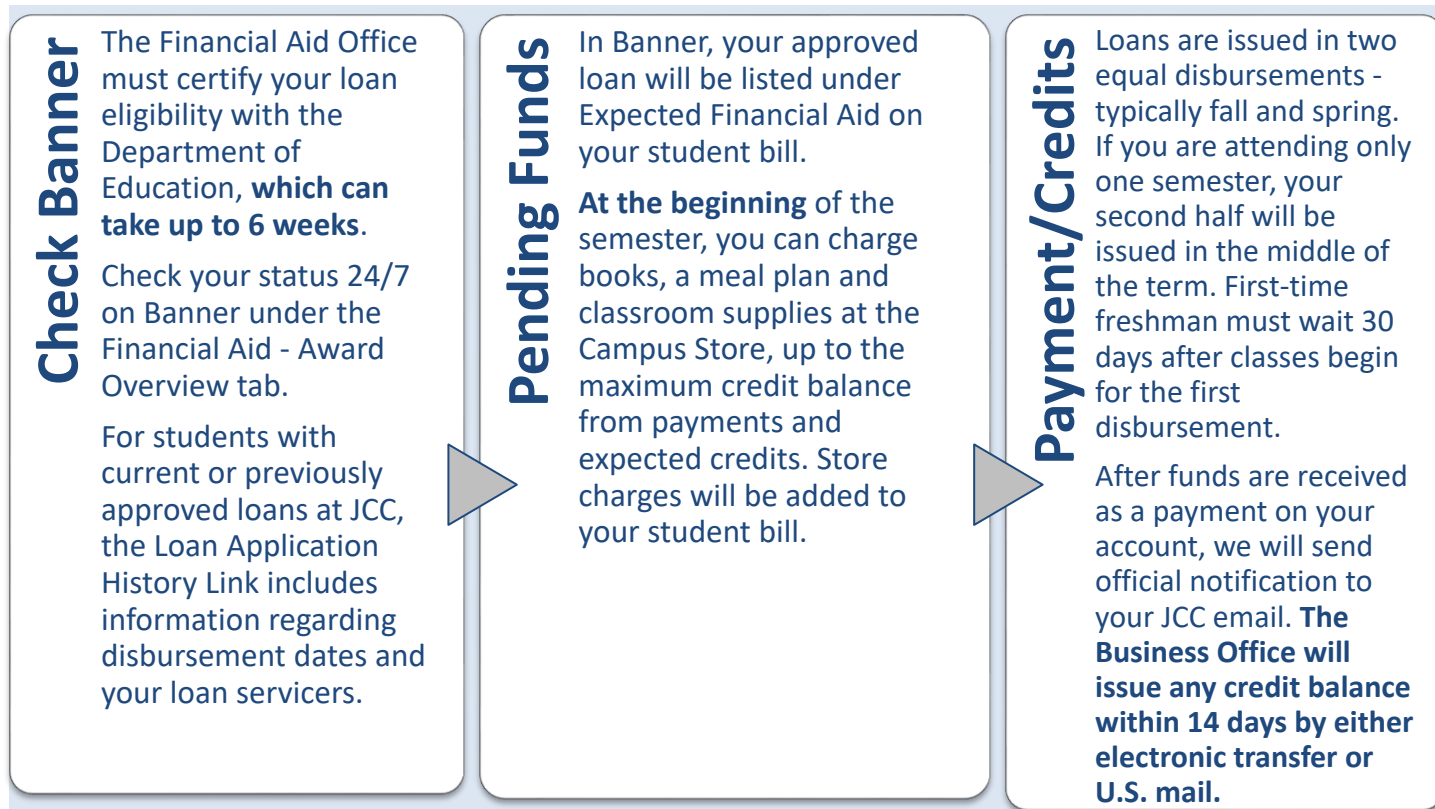


How will my loan be processed, and how can I track my loan at JCC?



Before submitting page 2 for a loan request, have you considered that you may not need a loan? Some students have enough in grants and scholarship aid to pay all of their direct college expenses. And, some students may only need to request some of their offered loan eligibility to help pay their direct college expenses. Please read and work through page 2 of this form. Tuition & fees estimates:

Full-time registration with NY State Certificate of Residency submitted: \$6,370 (\$3,185 each semester)
 Part-time registration with NY State Certificate of Residency submitted: \$251 per credit hour
 Full-time registration, non-NYS resident: \$11,590 (\$5,795 each semester)
 Part-time registration, non-NYS resident: \$468 per credit hour

Textbooks & Supplies estimates: \$600 for each semester if registered full-time (\$150 per class if part-time)
