Course Title: Poverty/Social Class/America

Course Abbreviation and Number: HUS 1220

Credit Hours: 1 credit hour. Course Type: Lecture

Course Description: This course examines the nature and extent of poverty in the United States, including the causes of poverty, poverty measurement, and beginning intervention strategies for individuals, communities, and professionals. Students will analyze a framework for understanding socio-economic diversity, and use the strengths perspective to improve instruction and service delivery to populations in need. This course is appropriate for anyone working with people in generational poverty, including those in the fields of education, human services, criminal justice, and the health care professions. This course integrates theory with practical intervention strategies.

Eligibility: ENG 1510 without supports or Corequisite: ENG 1510 with supports.

Student Learning Outcomes:

Students who demonstrate understanding can:

- 1. Recognize the dynamics and consequences of generational poverty;
- 2. Analyze the impact of the socio-economic class system in America for people living in generational poverty, middle class and wealth
- 3. Apply a strengths based model of intervention when working with persons in poverty
