INSTITUTIONAL COURSE SYLLABUS

Course Title: Health Restoration/Maint II

Course Abbreviation and Number: NUR 2520

Credit Hours: 8

Course Type: Lecture/Lab

Course Description: Students will continue to develop the National League for Nursing (NLN) Associate Degree (AD) Competencies (professional behaviors, communication, assessment, clinical decision making, caring interventions, teaching, and learning, collaborating and managing care) and Quality and Safety Education for Nurses (QSEN) competencies, and the three roles of the AD nurse (provider of care, manager of care, and member within the discipline) with an emphasis on the role as manager of care. Course work emphasizes individuals experiencing complex acute and chronic biophysical and mental health deviations. Using a variety of healthcare settings, students will provide safe, holistic, culturally competent patient centered care across the life span. Emphasis will be placed on the care of patients with the following health alterations: oxygenation, perfusion, sensory perception, tissue integrity, cellular regulation, and psychosocial.

Prerequisite: NUR 2510 and NUR 2550. Corequisite: NUR 2360 and NUR 2560. Prerequisite/Corequisite: MAT 1540.
